AMENDMENT N.01

TO

**DOUBLE DEGREE AGREEMENT ON MASTER'S LEVEL IN CHEMISTRY BETWEEN
JUSTUS LIEBIG UNIVERSITY GIESSEN, GERMANY
AND
UNIVERSITY OF PADUA, ITALY,
DEPARTMENT OF CHEMICAL SCIENCES**

Concluded between the Università degli Studi di Padova, Italy, hereinafter referred to as UNIPD, with legal address in via VIII Febbraio 1848, 2, 35122 Padova-Italia, represented by its Rector Prof. Daniela Mapelli, and Justus Liebig University Giessen, Germany, hereinafter referred to as University of Giessen, with legal address in Ludwigstraße 23, 35390 Gießen, Germany, represented by its President Prof. Dr. Katharina Lorenz.

The parties jointly agree to modify the agreement as follows:

1. Add the following clause to Appendix "Double Degree Agreement on Master's level in Chemistry between Justus Liebig University Giessen, Germany, Faculty of Biology and Chemistry and University of Padova, Italy, Department of Chemical Sciences"

"Application and Entry Requirements

omissis... Following partner universities' academic coordinators' approval (including confirmation of study plan and supervision) students are provisionally admitted to the double degree programme by their home university. Selected students will be finally admitted to the host institution only after completing their first year of studies for at least 48 credits/CP at the home institution before their mobility period. Students are strongly encouraged to acquire all the first year 60 credits/CP before the mobility period. In case this proves impossible, subject to verification, in each individual case, in terms of study plans and examination recognition, host institutions will provide the possibility to acquire the missing first year credits/CP during the mobility period.

Selected students from JLU, sending institution, are allowed to attend the 3rd semester at UNIPD, hosting institution, in both summer or winter semester provided they have completed their first year of studies for at least 48 credits/CP at JLU institution before their mobility period. Students are strongly encouraged to acquire all the first year 60 credits/CP before the mobility period."

The rest of the articles of the original agreement signed between UNIPD and University of Giessen remain unchanged. This amendment will complete the original agreement and both documents will be considered as a whole.

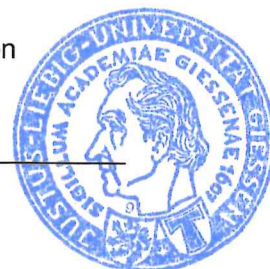
